I understand that should my account become past due by February 1<sup>st</sup> I will forfeit my slip and that should I become past due after April 1<sup>st</sup> I am at risk of losing the use of my slip until I become current.

***I certify that I have read and understand the Marina Rules & Regulations on this document as well as the enclosed material.***

I agree to have bumper cushions on the mooring side of my boat, to have rubber snubbers on my mooring lines where ever possible, and to take down my canopy while my boat is docked. I agree to hold W.L.E.P.O.A. harmless in case that an emergency may arise, and Wallenpaupack Lake Estates must take immediate action in order to save my watercraft or protect the docks from damage. In the event that my watercraft needs to be pumped out, I agree to pay a \$25.00 fee for this service. In the event that my canopy needs to be taken down, I agree to pay a \$50.00 fee for this service. Both fees paid to the Administration Office. Further, I understand that I am financially responsible for any damage to the Marina slip and adjacent dock(s) done by my boat/watercraft. See Marina Rules and Regulations - Rule #8.

I understand the inherent risks that exist with boating and around floating docks, causeways, and marinas.

I agree to hold W.L.E.P.O.A. harmless from any claims, losses, damage, and expenses for any personal injury or property damage arising out of or in connection with any use of the marina facilities by me, my family, guests, or invitees.

I certify that all the information provided above is true to the best of my knowledge and that I am fully insured, and my boat/watercraft is registered either in my home state or the State of Pennsylvania.

I understand that the Marina closes, and my boat/watercraft **MUST** be out by October 15<sup>th</sup> of each year, otherwise I will be subject to a **fine of \$250.00 the next day**. Additionally, your watercraft will be towed to another location at your expense 3 days later.
