**Minimum liability coverage for Golf Carts and UTV's who utilize WLEPOA property will be \$100,000/\$300,000 and WLEPOA designated as an additional insured, certificate holder or additional interest on the policy. *If you are covered under your homeowners, then we need the portion of the policy that shows the GC/UTV can be driven on public/private roads within a community/development. Or, something from your agent with your policy # stating that the GC/UTV is covered while driven on our WLE roads.***

**Insurance showing the above coverages must be sent with application & fee.**

Golf Cart operated by those 17 years of age and younger remains in between the hours of 7:00 AM to 11:00 PM. Existing 15-minute grace period after WLE functions. ALL Golf Carts and UTVs No longer have a curfew for those 18 years and older with a valid driver's license.

All drivers of Golf Carts and UTV's must, while operating said vehicles, be in possession of a State or WLEPOA issued driver's license/permit with photo and birthdate. Drivers may be stopped and asked to produce said license/permit at any time by officers of the WLEPOA Public Safety Department, which is agreed to and signed by the registrant when said vehicle is registered with WLEPOA.

It is recommended for safety equipment, including but not limited to rollover protection devices and seatbelts for golf carts.

Officers of the WLEPOA Public Safety Department shall be authorized to make random stops and Safety checks of Golf Carts and UTV's on WLEPOA property.
